



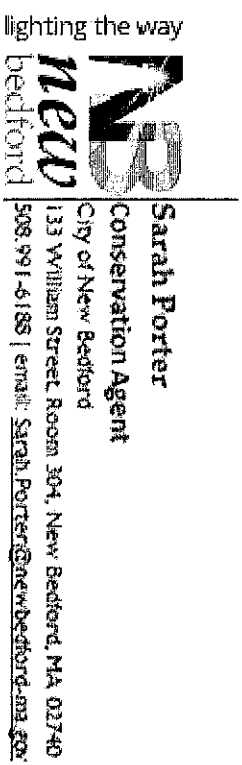

UNIFORM DURABLE POWER OF ATTORNEY

I, **ETHEL M. LAWRENCE** of *686 Hawthorn Rd* ~~Street~~, New Bedford, Massachusetts, do make, constitute and appoint **GEORGE P. LAWRENCE** of *679 Hawthorn Rd.*, Massachusetts my Attorney-in-Fact, to act for me and in my name.

1. To demand, sue for, collect, recover and receive all goods, claims, debts, moneys, interest, and demands whatsoever now due, or that may hereafter be due, or belong to me (including the right to institute any action, suit, or legal proceeding for the recovery thereof), and to make, execute, and deliver, receipts, releases, or other discharges therefor, under seal or otherwise.

2. To make, execute, endorse, accept, and deliver any and all checks, drafts, notes, and other instruments; to deposit or withdraw any funds belonging to me in one or more savings or checking accounts in the discretion of my attorney;

3. To pay all sums of money at any time or times that may hereafter be owing by me upon any check, draft, or note made, executed, endorsed, accepted and delivered by me or for me, and in my name, by my said attorney.

4. To sell any and all shares of stock, bonds, or other securities now or hereafter belonging to me that may be issued by any association, trust or corporation, whether private or public; and to make, execute, and deliver an assignment or assignments or any such shares of stocks, bonds, or other securities.

5. To defend, settle, adjust, compound, submit to arbitration, and compromise, all actions, suits, accounts, reckonings, claims, and demands, whatsoever, that now are, or hereafter shall be pending between me and any person, firm, or corporation, in such manner, and in all respects as my said attorney shall deem fit;

6. To hire accountants, attorneys-at-law, clerks, workmen, and others; and to remove them and appoint others in their place; and to pay and allow to the persons to be so employed, such salaries, wages, or other remuneration as my said attorney shall deem fit.

7. To enter into, make, sign, execute, and deliver, acknowledge and perform any contract, agreement, writing, or thing that may, in the opinion of our said attorney be necessary or proper to be entered into, made, or signed, sealed, executed, delivered, acknowledged, or performed, including without limitation, any contract for the sale of real estate, for consideration or no consideration, owned by me and any deeds for the conveyance of the same.

8. Without in any way limiting the foregoing, generally to do, execute, and perform any other act, deed, matter, or thing whatsoever, that ought to be done, executed, and performed, or that in the opinion of my said attorney, ought to be done, executed, or performed of every nature and kind, whatsoever, as fully and effectually as I could do if personally present.

9. This **POWER OF ATTORNEY** shall not be affected by my subsequent disability or incapacity, as defined by the Uniform Durable Power of Attorney Act, M.G.L. Ch. 201B, Section 1(b).

10. This **POWER OF ATTORNEY** is to be used to nominate **GEORGE P. LAWRENCE** as Conservator or Guardian of my Estate and my Person should protective proceedings be commenced, to be appointed except for good cause or disqualification, as provided in the Uniform Durable Power of Attorney Act, M.G.L. Chapter 201B, Section 3(b).

11. This appointment and these powers to take effect on September 13, 2006 and to extend until such time as I or my fiduciaries give notice of termination.

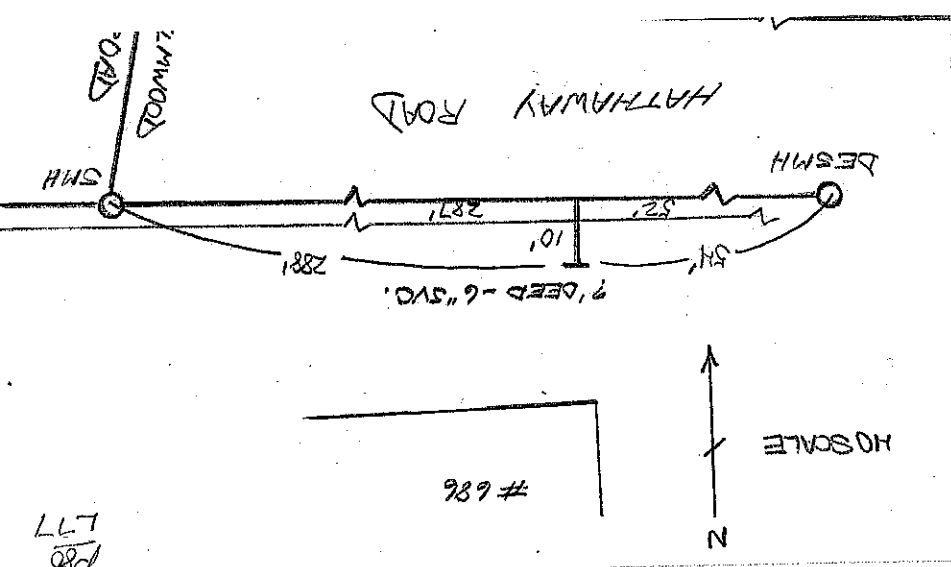
