To the City Council

Gentlemen:—

The undersigned request permission to locate poles and wires, conduits and manholes, or other fixtures, including the necessary sustaining and protecting fixtures, in, along and across the following public way or ways:—

From Comcast vault at the intersection of Union Street and 2nd St, place conduit in side walk, and across 2nd st. Total distance approx. 85'.

Number of poles, conduits or manholes

One 3" PVC conduit

Wherefore it asks—they ask that after due notice and hearing as provided by law, it or they be granted a location for and permission to install and maintain poles and wires, or conduits and manholes, together with such sustaining and protecting fixtures as it or they may find necessary, said poles and wires, or conduits and manholes to be located substantially in accordance with the plan filed herewith marked

Petitioner or petitioners agree to reserve space at a suitable point on each of said poles for the fire, police, telephone and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.
