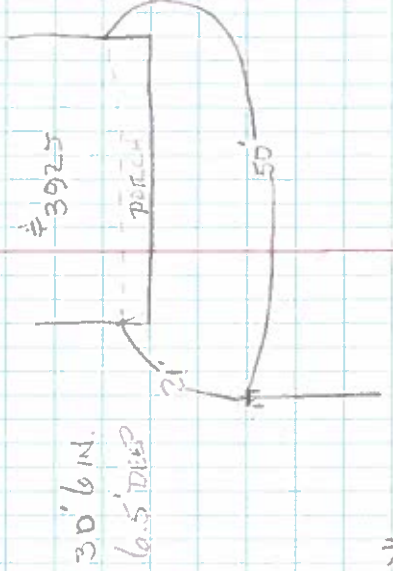

Amanda, We do have a mapped resource area just down gradient from this 3913 Acushnet Ave location. They do not need to file anything with Conservation for this abandonment but if we can put a note on their permit to have the tank pumped before abandoning and backfilling, it would be beneficial if that is not already part of the plan.

Also, do we have a map of all the septic systems currently in use in NB? Does the Health Dept get made aware of these abandonments? Joe Carvalho at the Health Dept permits them when they go in, but I'm told they do not have an updated map of them. Maybe something we work towards?
