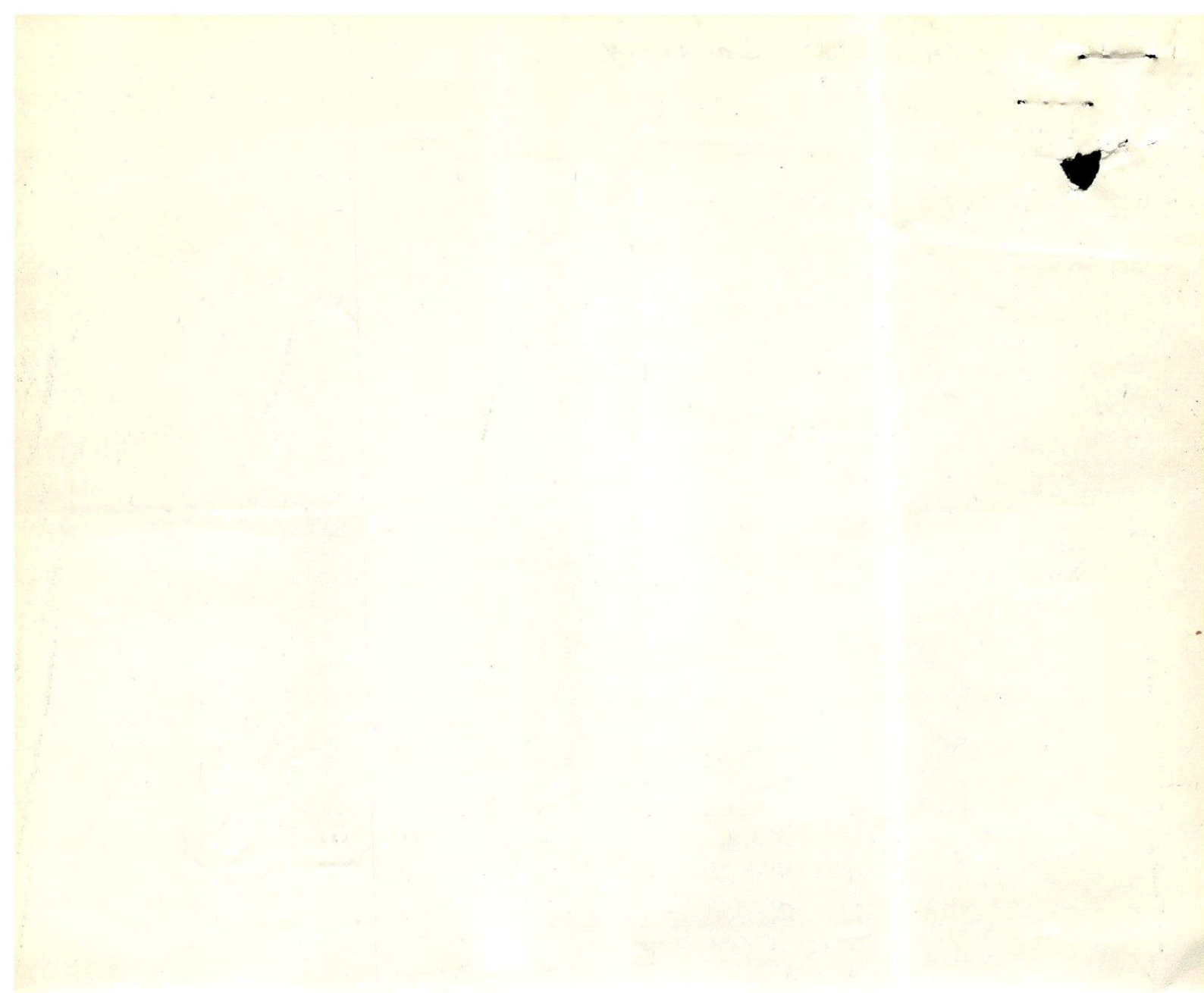
NOTICE OF SEWER AGREEMENT

In consideration of the City of New Bedford permitting Armand Sansoucy of 929 Maplewood Street, New Bedford, to make a connection to a public sewer, the said parties hereto and their heirs and assigns, being owners of the property located at the south side of Montrose Street in New Bedford and which are described on the City of New Bedford Assessor's Plats #130 as Lots 27, 28, 29, 30, 31 and 32, however, they shall be further described as being divided into two adjoining lots and being numbered 1050 and 1054 Montrose Street, New Bedford, and the said Armand Sansoucy and subsequent purchasers thereof, and their heirs and assigns, do hereby agree to bear jointly the cost of the sewer drains serving the above described property from the point where said sewer drains combine into a single pipe to the point where said single pipe enters into the public sewer on Adelaide Street.

The above described statement effects land as described in a deed from Stanley M. Mastera to the said Armand Sansoucy dated March 13, 1973 and recorded in the Bristol County (S.D.) Registry of Deeds in Book 1659 Page 662 and shall effect a division of the land as described in said deed into the two lots and a house being built upon each which will be numbered 1050 and 1054 Montrose Street.

All future conveyances by the said Armand Sansoucy shall be



subject to this agreement.
