AGREEMENT FOR MAINTENANCE COSTS OF SEWER SECTION

May 8, 1979

In consideration of the City of New Bedford permitting BERTHA M. BEDARD, 200 Pitman Street and JOSEPH L. AND DOREEN T. ALMEIDA, 258 Wilson Street to make connection to a public sewer, the said parties hereto, their heirs and/or assigns, being owners of property located at 200 Pitman Street, Plot 95 and Lots 146 and 147 and 258 Wilson Street, Plot 88, Lot 105, do hereby agree to bear jointly the cost of maintaining the private sewer serving the above described property, from the point where the individual house sewers combine into a single pipe to the point where said single pipe enters into the public sewer.

However, in cases in which the location requiring maintenance is found to be behind or above the point of connection of one or more of the above described individual house sewers, the cost shall be borne jointly by those remaining property owners which have joint use of the private sewer at such location.
