EASEMENT

I, Richard C. Noel, of New Bedford, Bristol County, Massachusetts, in consideration of One Dollar paid, hereby grant to Willard K. Langill, Jr., and Dorothy M. Langill, husband and wife, as joint tenants, both of 1578 Cove Road, in said New Bedford, an easement for the purpose of installing and maintaining sewer drains leading from property of the Grantees to Norwell Street over the following described parcel of land in said New Bedford: *AND RESTORE LAND TO ITS PRESENT CONDITION.*

Beginning at the southeasterly corner of Lot 39 on Plan of Lane owned by Patrick Sweeney, Trustee, dated June 28, 1926, recorded in Bristol County, S.D., Registry of Deeds in Plan Book 19 Page 91; thence northerly in the westerly line of Norwell Street 20 feet; thence northwesterly in a line at right angles to said Norwell Street 30 feet, more or less, to land of the Grantees; thence southeasterly in line with said Grantees' land 30 feet, more or less, to the southwesterly corner of said Lot 39; thence easterly in line of land of owners unknown 16.81 feet to the point of beginning.

Said easement is further described as the southerly 20 feet of said Lot 39 as conveyed to me by deed of Ronald DaCosta and Nancy DaCosta recorded in said Registry in Book 1776 Page 787.
