# AND USE PRIVATE SEWER LINE

This agreement is made and entered into this 3 day of 1985, by and between William R. Collins, M.D., Presiding Trustee of the Field Street Realty Trust established by Agreement and Declaration of Trust dated July 24, 1971, and recorded in the Bristol County (S.D.) Registry of Deeds, Book 1622, Page 152, of 225 Field Street, New Bedford, Massachusetts (hereinafter "Field Street Realty Trust"), and John W. Folino, Jr. of 13 Industrial Drive, Mattapoisett, Massachusetts (hereinafter "Folino").

### WITNESSETH:

WHEREAS, the Field Street Realty Trust is the owner of certain real property with the building thereon situated on the west side of Field Street in New Bedford, Massachusetts, known as 225 Field Street, New Bedford, Massachusetts, being shown as Lot 309 on New Bedford Assessors Plat No. 35, and being more particularly described in deed dated July 1, 1971, and recorded in the Bristol County (S?D.) Registry of Deeds, Book 1622, page 167; and

WHEREAS, Folino is the owner of certain real property situated on the east side of Field Street in New Bedford, Massachusetts, being parts of Lots 101, 102 and 103 on New Bedford Assessors Plat No. 35, and being more particularly described in deeds dated January 15, 1985, and recorded in said Registry in Book 1912, Page 1040 and 1041; and

WHEREAS, the Field Street Realty Trust previously installed and is the owner of a private sewer line servicing the building situated at 225 Field Street and running from said building to a sewer

.  manhole on Field Street and from that sewer manhole through Field Street to a connection with the City of New Bedford sewer line on Grape Street; and

WHEREAS, Folino desires to construct an office building on his premises, and it is necessary that he install a private sewer line to service said building; and

WHEREAS, the Field Street Realty Trust has agreed to grant, convey and release to Folino the right to connect a sewer line from Folino's property to its sewer line at the sewer manhole on Field Street and the right to use its private sewer line upon the terms and conditions hereinafter set forth.

NOW, THEREFORE, in consideration of the mutual covenants, conditions and agreements herein contained, the parties agree as follows:

#### 1. Grant of Right.

The Field Street Realty Trust hereby grants, conveys and releases to Folino, his successors, heirs and assigns, the right to connect a sewer line running from Folino's property to the Field Street Realty Trust's sewer line located at the sewer manhole on Field Street and the right to use the Field Street Realty Trust's private sewer line from its location at the sewer manhole through Field Street to a connection with the City of New Bedford sewer line on Grape Street, as shown on the plan attached hereto and by this reference incorporated herein.

#### 2. Repairs and Maintenance of Private Sewer Line.

During the first three months following Folino's connection to Field Street Realty Trust's sewer line, Folino agrees to pay all costs of repairs and maintenance to the line, regardless of the



location requiring repair and/or maintenance, including any repairs and/or corrections made necessary by virtue of Folino's connection to the line. Thereafter, the parties hereto agree to share equally in the cost of maintaining and repairing the private sewer line serving the above-described properties from the point where the individual building sewers combine into a single pipe to the point where said single pipe enters into the public sewer on Grape Street. However, in cases in which the location requiring repair and/or maintenance is found to be behind or above the point of connection of one or both of the above described individual building sewers, the cost shall be borne by the property owner(s) who have use of the private sewer at such location.

# 3. Right to Run With the Land.

This agreement granting the right to connect to and use private sewer line shall run with the land and shall be binding on and inure to the benefit of the parties hereto, and their respective successors, heirs and assigns.

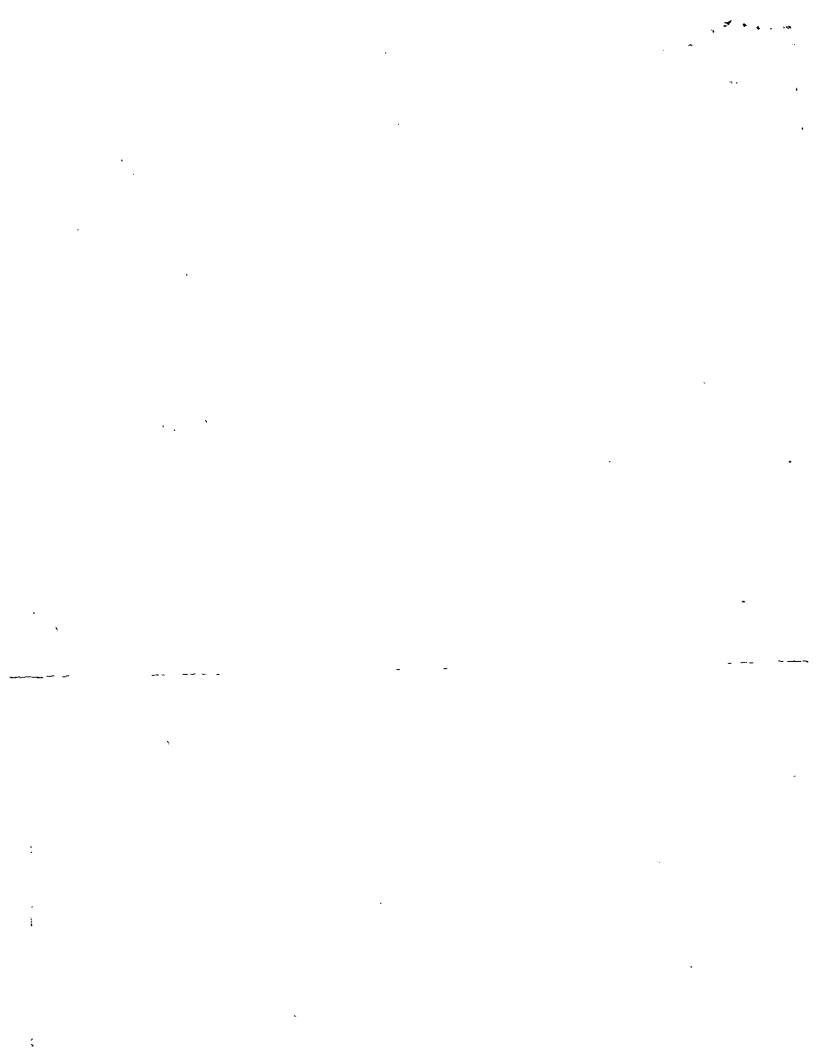

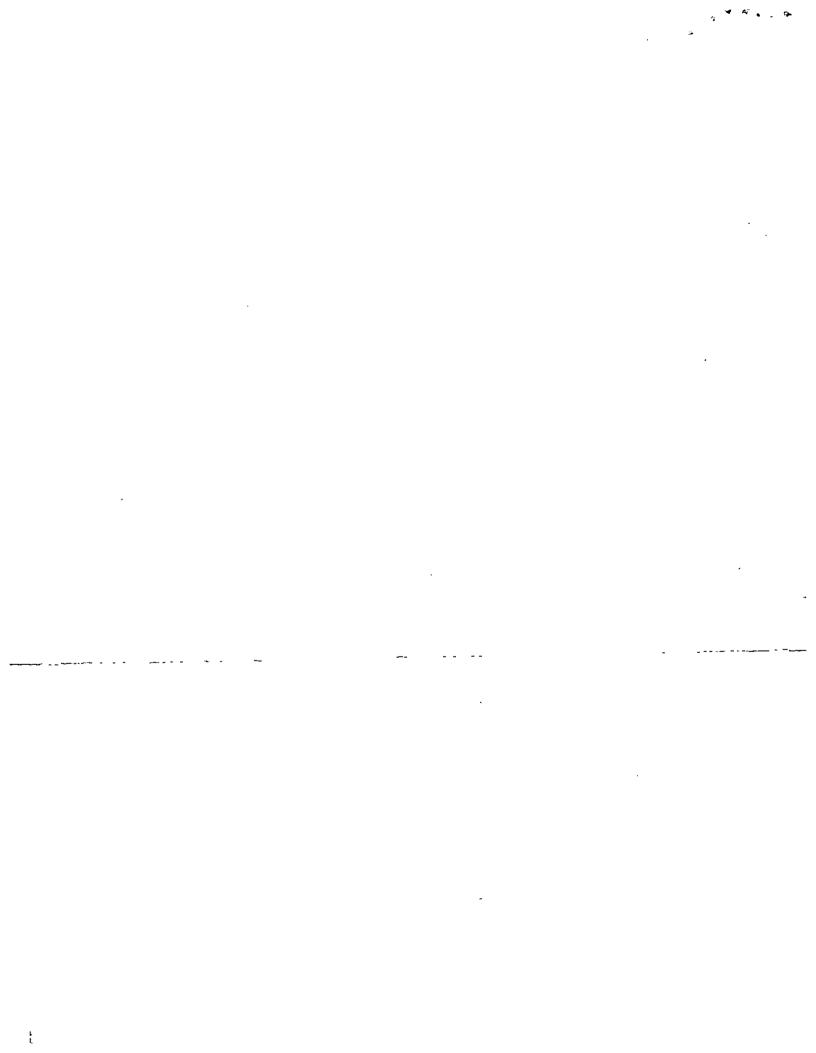
