- d) A Filing and Inspection Fee of \$ 50.00, plus an Entrance Fee of \$ where applicable, must accompany this application.
- e) Other requirements: TO CONNECT TO NEW M.H. MT PLEASANT ST
TO EXISTING M.H. CEDAR GROVE ST. (INSPECTION ONLY)
