d) A Filing and Inspection Fee of \$ 50.00, plus an Entrance Fee of \$ _____ where applicable, must accompany this application.

e) Other requirements: INSP. ONLY - FRISCO'S ASPHALT PAVING TO DO ALL WORK - SEWER TO BE EXTENDED 26'± BEFORE WY TO HOUSE - DRAIN TO BE EXTENDED 52'± N. of SDMH. BEFORE WY TO HOUSE.
