- d) A Filing and Inspection Fee of \$ 100.00, plus an Entrance Fee of \$ \_\_\_\_\_ where applicable, must accompany this application.
- e) Other requirements: clasp only - Nemasket Const. to do all work - 3306 P.D. included on Permit #22094

Applicant agrees to abide by the above terms, as well as all pertinent ordinances of the City of New Bedford, and such other special rules as the Commissioner of Public Works may deem necessary.
