d) A Filing and Inspection Fee of \$ 150.00, plus an Entrance Fee of \$ [blank] where applicable, must accompany this application.
e) Other requirements: CONNECT W/DROP @ EXIST. M.H. INSP. ONLY. S.D. CONN. ONLY TO COMBINED S./S.V. W. STREET.
