- d) A Filing and Inspection Fee of \$ 150.00, plus an Entrance Fee of \$ where applicable, must accompany this application.
- e) Other requirements: WSP ONLY - PICO TO DO ALL WORK - 3306RD -
TO BE CONNECTED TO A STUB AT PROPERTY LINE -
