d) A Filing and Inspection Fee of \$ 150.00, plus an Entrance Fee of \$ _____ where applicable, must accompany this application.

e) Other requirements: INSP ONLY - FRANKLIN BROS. TO DO ALL WORK TO BE CONNECTED TO A STUB AT PROP. LINE 35'± E. of W. Rd. FRENCH BLVD 330 GPD
