- d) A Filing and Inspection Fee of \$ 150.00, plus an Entrance Fee of \$ where applicable, must accompany this application.
- e) Other requirements: INSP. ONLY - THROUGH EASEMENT TO LOT IN QUESTION.

Applicant agrees to abide by the above terms, as well as all pertinent ordinances of the City of New Bedford, and such other special rules as the Commissioner of Public Works may deem necessary.

MARION W. TURNER of New Bedford, Massachusetts grants to Constance E. Guay, of 328 Rim Road, East Peoria, Illinois, 61611, Barry J. Poole, of 830 Francis Drive, Vista, California, 92084 and Janise Montieth, of 6019 Century Drive, San Antonio, Texas, 78242.

The perpetual right and easement to enter upon the grantors property described below in order to construct, install, maintain and repair water and sewer services for the benefit of, and as appurtenant to the grantees ownership of the premises shown as "B" on the plan of land hereinafter referred to.

The easement area is bounded and described as follows:

The land in New Bedford, Bristol County, Commonwealth of Massachusetts.

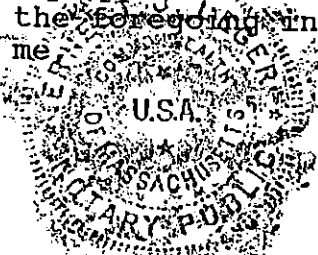
