Please be advised that the construction of the two inch and three inch sewer force mains recently installed in Flaherty Drive were inspected by Field Engineering. Testing of the completed mains was inspected by Mr. John Perry of the Department of Public Infrastructure.

The two inch main is only for the use of American Flexible Conduit at their new plant off Flaherty Drive and the three inch main is for future use should the roadway be extended.

Since final completion of this roadway project is not scheduled until next spring, "As Built" drawings from the contractor will not be available until that time.

Please advise us if additional information is required at this time in order for a building permit to be issued to American Flexible Conduit.
