Application for Laying Water Main

May 11, 2010

To The Commissioner of The Department of Public Infrastructure:

I, the undersigned, hereby make application for the laying of an 8-inch water main on Wildwood Rd.; from exiting terminus southerly starting with an 8 inch gate valve heading southerly approximately 153 feet ending with a department approved automatic flushing hydrant.

The contractor in accordance with the specifications of the Department of Public Infrastructure shall install the above-described extension.

It is further understood and agreed that the owner shall apply for an application for service(s) from this proposed line of main pipe as described herein; the applicant shall pay the cost of installing the service line from the main into the property of the applicant within 30 days from the laying of said service line. The owner shall furnish an AS-Built plan at the completion of the project. The Department reserves the right to approve or reject any or all petitions, for the best interest of the City.

**Inspectional fees for the installation of water main extensions shall be \$4.00 per linear foot.
153 feet x \$4.00 = \$612.00 Application Fee \$450.00 Total: 1062.00**

The water sample and pressure test fee of \$150.00 each shall be billed separately to the owner at time of inspection.

It is further understood and agreed upon that the Department of Public Infrastructure shall obtain a recorded easement from the registry of deeds to maintain said water line.
