As you are aware, the new dwelling located at the above lots is being referred to as "948 Brantwood St." After searching for this address in our address cards, we found that this was not a legal address issued by us (City of New Bedford DPI-Engineering Div.) for this dwelling. Our cards do not show this address as having been assigned to this, nor any other dwelling in that vicinity. The owner/contractor/developer is the one that is suppose to contact Engineering once the main door is framed for us to go out and do measurements. After further research, it turns out that the main door of this dwelling faces Upland St., so this address should not have made much sense to persons familiar with the house. Yet, it was never questioned, until recently when the request came in to DPI from the realtor for a final reading.

Therefore, yesterday I asked Manny Silva to visit the site to obtain measurements for me, and I assigned the address of #476 Upland St. to the structure late this morning. Please kindly adjust your records, and proceed with the preparation of the final read requested. I ask that everyone being copied in on this message to also reflect the proper legal address assigned today.

I have left a Voice Mail for George Hodge/GEH Central Heating indicating the proper address, and I have also contacted Dorothy in Assessors, Kristen in Inspectional Services, Melissa at KAM Realty and Attorney Kevin Medeiros in regards to this matter. Thank you.
